BIL Federal Funding

\$1.3 billion in Federal Funding for road construction 2022 -2026.

Projects must be; engineered with cost estimates.

will be awarded state 80% / 20% township SMA.

Bids will be let/awarded by Wis.Dot. not town boards.

Federal Funding for specific year does not roll over.

Wisconsin will receive \$173 million, Surface Transportation projects (STP Local) for 2022, 91% addition to State funding past available.

Applications open now & must be submitted by April 1, 2022. Project plans, cost & estimates (PSE) in by Aug 1, 2022, let & bidding in November 2022.

Projects for 2022 must be simple, cannot include wetland management, railroad, utilities & right of way purchases.

Project applications for 2023-26 open now & must be submitted by June 3, 2022, (PSE) by July 2022.

2023 Wisconsin will receive approximately \$193 million for 2023.

2024 Wisconsin will receive \$2.13 million.

2025 Wisconsin will receive \$2.32 million.

2026 Wisconsin will receive \$2.53 million.
