People won't call if they know getting a bill. Volunteers may consider themselves employees now vs volunteers. Premiums may increase if we change. Trying to come up with revenue for addition. Update on Road Construction and Road Issues: Prairie Lake Rd took hairpin turns out. Fire station sealing mid Julu. County L cuts in road they milled to our joints.
